- * Adopt the resolution to not increase any school district tax for the 2022-2023 school year, at a rate that exceeds the index as calculated by the Pennsylvania Department of Education.
- * Approve lowering the tax for M & C Real Estate, LLC on 88 School Street, Rimersburg, PA 16248 (Bill# 00272, Parcel# 27-004331) from \$44,268.10 to \$1,922.78. ****Motion Failed****
- * Approve the Memorandum of Understanding entered into on December 9, 2021 by and between the Union School District and the Union Education Association.
- * Approve the 2020-2021 Union School District Financial Statements.
- * Approve the Pixellot Supplemental Agreement Addendum to add a Pixellot automated production system to the Union High School.
- * Motion For The Adoption Of A Resolution, As Presented By Note Counsel, Which Enables The District To Finance The Costs Of Its Energy Savings Capital Project Through The Issuance Of A Note, Series Of 2022, To Be Delivered To Webster Public Finance Corporation. The Text Of The Resolution Shall Be Incorporated Into The Minutes Of This Meeting, And Is A Document Which Can Be Summarized, By Its Caption, As Follows:
 - Authorizing The Incurring Of Nonelectoral Debt By The Issuance Of A General Obligation Note In The Aggregate Principal Amount Of Four Million Dollars (\$4,000,000.00); Covenanting To Pay, And Pledging All Available Revenues For The Payment Of, The Note; Fixing The Form, Interest Rate, Maturity, Redemption And Other Provisions For The Payment Thereof; Accepting A Proposal For The Purchase Of The Note; Authorizing A Filing Of Required Documents With The Department Of Community And Economic Development; Ratifying And Directing Certain Actions Of Officers; And Making Certain Other Covenants And Provisions In Respect Of The Note
- * Accept the letter of retirement from Educational Aide, Cindy Carr, effective December 7, 2021.
- * Approve an unpaid Family Medical Leave to Employee #184, effective January 20, 2022.
- * Approve to extend the unpaid leave of absence to Employee #416 from December 9, 2021 through January 20, 2022 unless released to come back sooner.
- * Approve the Course Catalog and Union School District Pathways to Graduation.
- * Motion to approve a disciplinary agreement in lieu of expulsion for student #6330848548.
