- * Exonerate the local tax collectors from the collection of delinquent 2017 per capita and occupation taxes.
- * Appoint Rick Hawk as the local auditor for the 2017-2018 fiscal year audit.
- * Grant permission to advertise bids for General Supplies.
- * Enter into a five year agreement with Windstream for the Internet Services.
- * Enter into a five year agreement with windstream from Building to Building for WAN Services.
- * Hire Heather Smith and Stephen Petrocy as Homebound Instructor for the 2017-2018 school year.
- * Hire Heather Smith as Summer Academy Instructor.
- * Hire Alicia Hetrick as Summer Academy Aide.
- * Add Brian Runyan to the substitute custodian list for the remainder of the 2017-2018 school year.
- * Ratify the July 1, 2018-June 30, 2023 agreement between the UESPA and the Union School District Board of Education.
- * Approve a 5 year Act 93 Agreement with Elementary Principal, Tom Minick, at an average 2.6% per year increase, effective July 1, 2019 through June 30, 2024, as per the terms of the negotiated contract.
- * Correct the previously approved Lil Dribblers dates to June 11-June 15th, 2018.
- * Correct the previously approved Summer Academy dates to June 18th--July 20th, 2018.
- * Grant permission to the Softball Team to sell Sarah's Snack Shack Coupons starting March 5, 2018.
- * Grant permission to the Girls Scouts to make improvements to the Rimersburg Little League Baseball Dugouts. They will be making bat and helmet holders, redoing the benches, adding trash cans, home & visitor signs, and adding dry erase boards.
- * Grant permission to Diana Thorpe and the Jr. High Volleyball team to use the High School Gym on Friday, April 6th and Saturday, April 7th for a Jr. High Volleyball Tournament.
- * Grant permission to Jacob Kosker to have Big Smiles Mobile Dentist provide services to students at the Union High School and Sligo Elementary on Tues., March 27th, and at Rimersburg Elementary on Mon., April 9th.
- * Grant permission to the Southern Clarion County Little League to make significant improvements to the baseball/softball fields located behind Sligo Elementary, Upper Field. The work is being done by a grant received from PNC-Eccles Foundation and the Southern Clarion County Little League will match that amount. The following work will be accomplished prior to opening day in May 2018:
 - Excavate 1000 sq. feet to a 2 inch depth, import and apply 3 loads of Fielder's Choice Infield mix.
 - Remove the existing lip (unsafe) and define turf edges
 - Laser grade the entire field with dual plane laser-controlled system
 - Rebuild the pitcher's area with packing clays and rebuild the batter's boxes with packing clays
 - Install new bases, anchors, and pitch plate, and condition the field with Pro's Choice Diamond Pro.
 - Trench and electric for pitching machine (required for games)
 - Rebuild the dugouts for teams.
- * Hire Fred Weaver as Head Track Coach for the 2017-2018 school year.
- * Hire Diana Thorpe as the 2018-2019 Head Volleyball Coach at the salary of \$2,660.00.
- * Hire Rachel Cumberland as the 2018-2019 Varsity Cheerleading Coach.

- * Hire Ean King and John Lundy as the 2018-2019 Cross County Co-Coaches.
